You Should Be the One to Determine **Your Own Destiny**

A true consent to settle policy provision is vital. Some policies claim to have consent, but also have arbitration clauses. If there is an arbitration clause, you have no right to consent. You must arbitrate. It is very important to understand your policy and not be surprised by clauses you don't understand.

Some companies say, "We've never lost a case," but they don't try cases. You will have to go to mandatory binding arbitration. That means you don't get your day in court to clear your name. You also lose the opportunity for an appeal.

A decision to settle a claim of professional negligence will follow you for years. It is imperative for you to be the one to control the decision whether to go to a jury verdict or settle before trial. At NCMIC, you hold the key to whether a case is settled or goes to court.

Sports, Government, Politics, & Chiropractors

Our nation is undergoing a political maelstrom as we struggle to understand and address such complex and volatile issues as law enforcement shootings, murdering of police officers, United Kingdom leaving the European Union, and a presidential election so unique it's difficult to summarize succinctly.

As athletes begin to engage in the political arena using a variety of methods to express their opinions, or entire college football teams threatening to refuse to play, we are all never far from politics. Sports talk on the radio and television, long a bastion of escapism, has been forced to engage in serious political issues.

In America, there is no escaping politics. Alexis de Tocqueville, famed French historian and author of *Democracy in America*, thought this paradigm made America great. It wasn't that America accomplished more through politics, or did so efficiently. It was that we possess the unique capacity to accomplish great things. Naturally, he provided a cautionary caveat, "The health of a democratic society may be measured by the quality of functions performed by private citizens."

Herein lies the true challenge for chiropractic in California. From a practical standpoint, we cannot avoid being impacted by politics and government. It is everywhere, at all levels of our lives. And if de Tocqueville is correct, that only the quality of what private citizens do will protect the health of a democratic society, it's not a stretch of logic to see that only what chiropractors do

as private citizens will protect and enhance the health of chiropractic.

Coming out of chiropractic college and realizing the challenges of making a living by providing your services is daunting. Starting a practice is daunting. Maintaining and growing a practice is daunting. Starting, maintaining, growing a family is complicated and challenging. In the midst of all this living of our lives, doctors of chiropractic are faced with the necessity of personally protecting and enhancing the health of their profession. It can't be protected and enhanced without their personal involvement. Because in a democracy, numbers equate to power. And power is not distributed equitably.

form used to great success by such august institutions as Stanford, Notre Dame, the Air Force Academy and others. Its greatest asset is its ability



to easily give access to our individual network of family, friends, and patients to garner small, or large donations. To give context of the impact this will have on chiropractic in California consider, if 1,000 chiropractors raise \$1,000, that is 50 people donating \$20, or 100 donating \$10, it equates to \$1 million dollars raised.

We have 13,247 licensed chiropractors

Chiropractors in the 2016 Olympics

With the 2016 Olympic Games upon us, we are happy to report that doctors of chiropractic play an ever growing role in the success of Team USA, including Bill Moreau, DC, managing director of Sports Medicine and Chief Medical Officer for the Rio Olympics. Here are a few stories of DCs who support the performance of athletes. Many other DCs play similar roles with athletes and athletic teams. Attend the CCA Sports & Rehab Symposium to learn how you can get involved or further hone your skill and expertise.

Dr. Dustin Glass Team Chiropractor, USA Volleyball



Even if he doesn't accompany the USA Volleyball teams to the 2016 Summer Olympics in Rio de Janeiro, Dustin Glass, D.C., CCSP®, who has served as the official chiropractor for the men's and women's teams for the past six years, says he'll be there with them in "spirit."

Dr. Glass, a 2003 graduate of Palmer College's San Jose

campus who maintains his primary practice, Sports Injury and Performance Care in Lake Forest, Calif., says he'll also feel a sense of "Palmer pride" for playing a hand in helping these skilled athletes achieve their Olympics dreams.

During the season (May to October), Dr. Glass visits the USA Volleyball training facility in Anaheim once or twice each week, where he meets with the head athletic-trainer for player evaluations, and to determine the appropriate treatment protocol for each athlete.

"Whether I go to Rio or not, just knowing that I'm helping these athletes accomplish something they've dreamt about means a lot," says Dr. Glass, who in addition to his role with USA Volleyball, also serves as chiropractic consultant for the Anaheim Ducks of the National Hockey League, and team chiropractor for the LA KISS of the Arena Football League (AFL).

Dr. Glass was among the Palmer alumni honored at the San Jose Campus Sports Council's 20-year anniversary reception in 2014 – and he credits his Palmer education for helping him achieve his sports-chiropractic goals.

"Palmer was the catalyst that allowed me to learn what it meant to be a 'sports chiropractor'," says Dr. Glass, who also served as team chiropractor for Los Angeles' inaugural AFL team, the Avengers.

Kevin Rindal, D.C. USA Swimming Chiropractor

Athletes who compete in the Olympics represent the best in their respective sports, and have invested hours of training and practice to reach the world's biggest sports stage.

The same can be said of the skilled sports-care specialists who help these elite athletes achieve their peak performance — including Palmer Davenport 2006 alumnus

In addition to Dr. Rindal, the USA Swimming multidisciplinary sports-care staff responsible for tending to the 40-member team (including five-time Olympian Michael Phelps) will include five medical practitioners, a medical doctor, two massage therapists and an athletic trainer.

Members were selected based on the recommendations from coaches and athletes who have traveled with the USA Swimming team for many years, along with their respective levels of sports-care experience.

"The great part about the USA Swimming medical staff is that we each bring different skills to the table, which helps the athletes perform at their highest level," said Dr. Rindal, founder of InHealth Sports Injury and Performance in Seattle (established

in 2011), where the practice team includes his brother, Curt Rindal, D.C., 2012 graduate of Palmer's San Jose campus.

Dr. Rindal's first Olympic-related assignment came at the recent 2016 USA Olympic Swimming Trials in Omaha, Neb. "Many say that the Olympic Trials is actually a tougher event than the Olympic Games, as each event at the Trials includes three or four of the top 10 swimmers in the world, competing for just two slots on the U.S. Olympic Team," said Dr. Rindal, whose pursuit of his Olympic dream began in 2009, when USA Swimming invited him to travel and treat the team at the USA Swimming Short Course National Championships.

"The difference separating first and fourth place can be a hundredth of a second. It's all about adjusting the small things, so that these athletes can perform to their full potential."

In 2011, Dr. Rindal completed the requirements to earn his Chiropractic Sports Practitioner certification (CCSP®), which qualified him to satisfy another USA Swimming sports-care requirement by serving a volunteer rotation at the Olympic Training

Center (OTC) in Colorado Springs.

"It is important to understand the dynamics of working with both the National Governing Body for a sport and the U.S. Olympic Committee, and how all of these health-care providers work together to provide coordinated care to the athletes; so all the steps that lead to these opportunities prepared me for positions with a greater level of responsibility," said Dr. Rindal, whose experience of providing care at international USA Swimming events includes the FINA World Championships, the Pan Pacific Games, and the Pan American Games. Dr. Rindal ranks his Olympic appointment as "the greatest honor I have had professionally."

"I look forward to representing the USA, and caring for these athletes who have earned a spot on the Olympic team after dedicating so much time and effort to grow and develop as athletes during the past five to six years that I've been able to travel with the team," said Dr. Rindal, one of six chiropractors in his family (including his father, uncle, cousin and two brothers).

Providing Gold-Medal Care for Olympic Athletes

The managing director of Sports Medicine, and Chief Medical Officer for the Rio Olympics, is a doctor of chiropractic — Bill Moreau, D.C. Frankly, having a chiropractor serve in a position of that level of responsibility and prestige would have been unthinkable not that long ago, and is a testament to all the hard work and dedication of people in the field working to get the message of chiropractic care out to the general public — like CCA President Dr. Leslie Hewitt accomplished with her radio interview (see story page 3).

Dr. Moreau oversees all USOC sports-medicine clinics, Olympic and Paralympic Games planning and staffing, and the USOC National Medical Network. He'll also be the first doctor of chiropractic to serve as a chief medical officer for an Olympic team at the upcoming Olympic Games in Rio de Janeiro, Brazil. Olympic and Paralympic athletes recognize the benefits of chiropractic and have been requesting for years that chiropractors be part of the health-care team during and between the Olympic and Paralympic Games.



He leads the squad of interdisciplinary health-care professionals who provide care to Team USA athletes through more than 25,000 Olympic and Paralympic clinical interactions each year. Team USA uses chiropractic care for many reasons, Dr. Moreau says. "Sometimes the care is for the daily ache and grind of the professional athlete, for sport performance outcomes or to treat injuries. Both summer and winter Olympic and Paralympic athletes have common injuries, as well as sport-specific injuries. You need to fully understand the demands of sport in order to best help the athletes."

Chiropractic care helps drive high-performance outcomes, Dr. Moreau adds, "by helping the athlete to reload and get ready for the next day of practice or competition grind. If we can help them recover and physically perform the next day, the target is for the athlete to reach the pinnacle of their potential at the Olympic or Paralympic Games." Access to conservative care such as chiropractic is important to the athletes. "The athletes vote with their feet by choosing those providers who can help them the best," he says. "The conservative health-care providers are in high demand."

Study Results: Use of Chiropractic in the VA Rising Steeply

The use of chiropractic services in the Department of Veterans Affairs (VA) health care system has seen a steep rise over more than a decade, according to research published in the *Journal of Manipulative and Physiological Therapeutics* (JMPT), the official scientific journal of the American Chiropractic Association (ACA).

The study's authors, who analyzed VA national data collected between 2004 and 2015, discovered an increase of more than 800 percent in the number of patients receiving the services of doctors of chiropractic. While authors attribute the increase to a natural growth of the chiropractic service, which was only implemented on-site at the VA in 2004, they also suggest it may be attributed to the successful performance of VA chiropractors and the perceived value of their care, among other factors.

"The fact that these services have expanded consistently and substantially beyond the minimum mandated level may suggest that some VA decision-makers perceive value in providing chiropractic care," the study notes. Key findings from the study show that:

• the annual number of patients seen in VA chiropractic clinics increased by 821 percent;



- the annual number of chiropractic visits increased by 694 percent;
- the total number of chiropractic clinics grew from 27 to 65 (9 percent annually);
- the number of chiropractor employees rose from 13 to 86 (21 percent annually); and
- female and younger patients received chiropractic care at VA clinics at a greater rate than the national VA outpatient population. "This demographic tendency is consistent with the cohort of veterans from the recent conflicts in Iraq and Afghanistan, which is known to have a high prevalence of musculoskeletal conditions," the study's authors note.

"ACA commends the VA for its important work to expand access to chiropractic services to the nation's veterans," said ACA President David Herd, DC. "It's vitally important that all of our veterans have access to non-drug approaches to pain management such as those offered by chiropractic physicians, particularly in light of the opioid epidemic that is gripping our country. Many veterans returning from overseas suffer from musculoskeletal ailments, which respond well to chiropractic's patient-centered and drug-free approach."

Doctors of chiropractic – often referred to as chiropractors or chiropractic physicians – practice a hands-on, drug-free ap-

proach to health care that includes patient examination, diagnosis and treatment primarily of disorders of the musculoskeletal system and the nervous system, and the effects of these disorders on general health. Chiropractors have broad diagnostic skills and are also trained to recommend therapeutic and rehabilitative exercises, as well as to provide nutritional, dietary and lifestyle counseling. 








It was further noted to the board that CCA has joined the Foundation for Chiropractic Progress as an association. This will provide new resources for CCA members to enhance the success of their practices.



SCU Celebrates 20 years Supporting AIDS Lifecycle

This year SCU celebrated 20 years supporting AIDS Lifecycle. Since 1996 SCU has provided chiropractic care to the more than 2,500 cyclists per year that make the 545 mile bike ride from San Francisco to Los Angeles, to help increase awareness and raise money to end HIV/AIDS. This year for the first time SCU had the opportunity to provide not only sports medicine chiropractic care but also acupuncture care to the riders and volunteers who made the journey.

Over the years ALC has become one of the most anticipated service opportunities for SCU interns. It draws in a diverse group of volunteers with a variety of expertise, backgrounds and certifications all eager to utilize their skills for a greater purpose. This year 27 sports medicine chiropractic interns, four under term students, and for the first time three acupuncture students were selected to participate in the event.

Their seven day journey through California is a grueling but rewarding experience. With day's beginning at the break of dawn and ending well after sundown it is their passion to heal people that keep them motivated through the long days.

The interns begin their day at day 6 am to rides stretch and tape cyclists for the day's journey. Once all the cyclists are on the road, they break down all their gear, load it and travel 65 to 110 miles to the next camp. By the time they have re-set up their treatment tent and gear cyclists are already making their way into camp and lining up for treatment. From around 1pm till 9 pm both chiropractic and acupuncture interns treat patients, providing soft tissue therapy, adjustments, rehab, acupuncture, stretching, Tui Na, and ear seeds.

Over the course of seven days, from San Francisco until Los Angeles interns saw approximately 1,700 patients. For those who participate in the event, it is a reminder of why they wanted to become health care providers and it strengthens their devotion to making people feel better.
