



# **United We Stand – Divided We Fall?**

It's no secret the marketplace of health care is changing as more and more people seek out alternatives to pills and scalpels. It's certainly no secret to allopathic providers who habitually clog the legislative process with an army of high priced lobbyists, generous campaign contributions, and prolific Independent Expenditure Committees. Preventing access to nonallopathic providers is priority one, two, and three for these organizations.

An organization like the California Medical Association (CMA) has 70 employees and a base operating budget of \$23 million. They have seven in-house lobbyists and two top five lobbying firms under contract. In only the last two election cycles they've spent over \$11 million on campaign contributions and another \$11 million plus on campaign activity. This doesn't mean they always get what they want, but they don't experience many bitter disappointments either.

The California Chiropractic Association has roughly twenty per cent of the licensed doctors in California as members. Its Political Action Committee is not nearly as robust as CMA's, but it's no piker either. Naturally, more members means more resources and as we grow as an association so shall our political clout, but we can't sit on our metaphorical hands while we wait for our numbers to grow.

The time is ripe for non-allopathic providers to seek out opportunities to form a united front on issues that benefit all. Together, the odds of success increase exponentially. The core argument in legislative circles of Non-allopathic providers is that only they can provide the quality care patients deserve. This argument has not only carried the day in legislatures throughout our country, but in the minds of its citizens as well.

Palmer College of Chiropractic commissioned Gallup to conduct the first-ever nationally representative annual survey measuring perceptions of and experiences with chiropractic among U.S. adults. (Click here for full report http://www. palmer.edu/uploadedfiles/pages/alumni/gallop-report-palmer-college.pdf) Previous research identified several barriers to widespread chiropractic use, including negative perceptions of chiropractic among both the public and physicians and unclear, narrow or nonexistent insurance coverage. The Gallup-Palmer study provides the first opportunity to test these assump-



tions and discover what U.S. adults think about chiropractic. Although there is much in the report that is encouraging, 86 percent of U.S. adults don't know the educational requirements needed for an individual to become a chiropractor. The result of this ignorance is a lack of confidence in chiropractic as health care providers. No such stigma, resulting from ignorance, exists for non-allopathic providers.

It is time for CCA to lead the charge in California for non-allopathic providers to work together on issues that benefit all and seize the opportunity this creates to educate politicians, their staff, and the public about the quality of care we all provide and our impressive qualifications to provide that care.

CCA is currently putting together just such a coalition to address the myriad of grievances with third party billers, disparity in co-payments, and other issues either driving us out, keeping us out, or wearing us down until we feel we have no other recourse but to capitulate.

Together we will make a formidable team in the halls of power and in the realm of public opinion. Alone, we run the risk of fighting over the scraps left behind by a sophisticated, wellfunded, and politically astute cadre of allopaths.

United we stand...Divided we fall.

# **Americans' Perceptions of Chiropractic**

A Gallup report released recently says that an estimated 33.6 million U.S. adults (14 percent) used chiropractic care within the last 12 months. Studies from other sources, including the 2012 National Health Interview Survey (NHIS), have measured yearly chiropractic use at about 20.6 million U.S. adults (8 percent).

Palmer College of Chiropractic commissioned Gallup to conduct this first-ever nationally representative annual survey measuring perceptions of, and experiences with chiropractic among U.S. adults. The survey will be repeated for at least two more years.

The report, officially named the *Gallup-Palmer College of Chiropractic Inaugural Report: Americans' Perceptions of Chiropractic*, also indicates that more than half of U.S. adults view doctors of chiropractic positively and agree they're effective at treating neck and back pain. However, nearly half of U.S. adults don't know whether their insurance covers chiropractic care.

"The goal of this groundbreaking project is to get an objective understanding of why adult Americans choose or don't choose to see a doctor of chiropractic," said Palmer College of Chiropractic Chancellor Dennis Marchiori, DC, PhD.

Results of the Gallup report are based on a Gallup Panel study of 5,442 adults, aged 18 and older, conducted February 16 to May 6, 2015, via the Web and by mail. The maximum margin of sampling error for this study is ±2 percentage points, with a 95 percent confidence level. The study can be read online. # **SURVEY EXECUTIVE SUMMARY**

About half of adults in the U.S. have been to a chiropractor as a patient. Fourteen percent of adults say they saw a chiropractor in the last 12 months, 12% say they saw a chiropractor in the last five years, and 25% say they saw a chiropractor more than five years ago.

- Women report that they have been to a chiropractor an average of two more times per year than men (11.5 visits vs. 9.4 visits, respectively).
- Women also have slightly more positive views of chiropractors in general, and female users are more likely than male users to want to see a chiropractor on a regular basis, even if they do not have pain.
- Although adults younger than 35 are less likely to say they have been to a chiropractor, there are positive signs that many from this group could become users if they were to experience neck or back pain. Adults younger than 50 are more likely than older adults to say a chiropractor would be their first choice if they had neck or back pain.

More than half of U.S. adults have a positive opinion about chiropractors and "strongly agree" or "agree somewhat" that they are effective at treating neck and back pain. These opinions hold true across all income and education groups. While adults' trust in chiropractors improves with exposure, recent use is limited to a small percentage of adults.

Nearly one in four U.S. adults strongly agree or agree somewhat that chiropractic care is dangerous, while more than a third say they don't know if it is dangerous. This uncertainty about the danger of chiropractic care rises to nearly half (47%) among people who have never been to a chiropractor, representing a possible barrier for nonusers to consider chiropractic care.

Among the 51% of U.S. adults who have never been to a chiropractor, there is also uncertainty regarding cost, expected number of visits, trustworthiness of chiropractors and the education required to become a chiropractor. About half or more of nonusers are unsure of these things. This represents an opportunity to educate many adults about chiropractors' qualifications and the benefits of chiropractic care.

A lack of knowledge about health insurance coverage for chiropractic care and sensitivity toward costs are also barriers for some. Nearly half of adults who have been to a chiropractor within the last five years (46%) say they would go to the chiropractor more often if it wasn't so expensive. Overall, about four in 10 adults in the U.S. believe chiropractic care is too expensive (43%) and think it requires too many visits (44%). Nearly half of U.S. adults do not know whether their insurance covers chiropractic care.

The key principles of the McKenzie Method are in line with modern chiropractic best practices as it promotes the body's potential for self-healing and emphasizes non-invasive treatment.

Part A of the course will take place January 22-24, 2016, and will examine how MDT can be applied to the lumbar spine. Part B will follow from February 20-22, 2016, and will focus on the application of MDT on the cervical and thoracic spine.
